The **R&R Auto Body "Paint My Ride Program"** is returning for the 2018 season and we're making it easy for you. If you wish to participate in this year's program, all you need to do is check the box above.

The **R& R Auto Body "Paint My Ride Program"** begins on May 5th and will conclude September 29th. Every eligible run will automatically be entered for you, except for *'fouls'* or *'red-lights'*.

The **R & R Auto Body "Paint My Ride"** program uses an innovative scoring formula that rewards a racer's consistency and performance over the entire racing season. To win a custom **R&R Auto Body** paint job a racer must have the best overall score factoring in reaction time, and their dial-in vs. actual E.T. It is similar to a major league pitcher's ERA where the lowest score is best. A racer must have a minimum of <u>13 rounds</u> to have their score considered in the final tabulation and **'foul'**, or "**red-light"** rounds do not count.

A driver cannot change class or permanent number at any time, even if the minimum number of rounds are fulfilled. Attempting to do so will automatically cause forfeiture of Paint My Ride eligibility!

The **R&R Auto Body** "**Paint My Ride**" is a non-transferable award and must be redeemed within 30 days of receipt. Redemption equates to meeting with **R&R Auto Body**, initiating the custom paint design and scheduling a vehicle drop-off date. The newly painted car will be displayed at the Annual Awards Banquet held each January. In the event of forfeiture, the prize will automatically be awarded to the racer with the next best average.

The requirements to participate include being a member of the **Finish Line Club**, checking the appropriate box above and placing the appropriate **R & R Auto Body Paint My Ride decals** on the race vehicle. This decal must be on the vehicle the entire season!

The track will enter the data for those racers who wish to participate in the program. Results will be updated before the following point's race.

#### **General Instructions**

Section references are to the Internal Revenue Code unless otherwise noted.

**Future developments.** For the latest information about developments related to Form W-9 and its instructions, such as legislation enacted after they were published, go to www.irs.gov/FormW9.

#### **Purpose of Form**

An individual or entity (Form W-9 requester) who is required to file an information return with the IRS must obtain your correct taxpayer identification number (TIN) which may be your social security number (SSN), individual taxpayer identification number (ITIN), adoption taxpayer identification number (ATIN), or employer identification number (EIN), to report on an information return the amount paid to you, or other amount reportable on an information return. Examples of information returns include, but are not limited to, the following.

• Form 1099-INT (interest earned or paid)

- Form 1099-DIV (dividends, including those from stocks or mutual funds)
- Form 1099-MISC (various types of income, prizes, awards, or gross proceeds)
- Form 1099-B (stock or mutual fund sales and certain other transactions by brokers)
- Form 1099-S (proceeds from real estate transactions)
- Form 1099-K (merchant card and third party network transactions)
- Form 1098 (home mortgage interest), 1098-E (student loan interest), 1098-T (tuition)
- Form 1099-C (canceled debt)
- Form 1099-A (acquisition or abandonment of secured property)

Use Form W-9 only if you are a U.S. person (including a resident alien), to provide your correct TIN.

If you do not return Form W-9 to the requester with a TIN, you might be subject to backup withholding. See What is backup withholding, later.
